Updated Directed Health Measures for Southwest Nebraska

On April 9th Governor Pete Ricketts announced the State's tenth COVID-19-related Directed Health Measure (DHM), which provides sweeping changes across the State. The DHM will be in effect April 10th and will last until April 30th unless renewed. A copy of the DHM is available on our website at www.swhealth.ne.gov.

Additions to the Statewide DHM Effective 04/10/2020

- All beauty/nail salons, barber shops, massage therapy services, gentlemen's clubs, bottle clubs, indoor theaters, and tattoo parlors/studios are closed until April 30, 2020.
- All organized team sports, youth and adult, including but not limited to club sports are suspended until May 31, 2020.
- Auto racing is now specifically listed in the public gatherings section which limits to ten patrons. (Drivers and their crews are considered patrons/invitees, not staff.)

State-Issued DHM Provisions (Apply Statewide) Effective 04/03/2020

- Imposes an enforceable, 10-person limit on <u>public gatherings</u>.
- Prohibits medical and dental <u>elective surgeries</u> and procedures.
- Requires <u>schools</u> (public, private, and parochial) to operate without students in buildings through May 31, 2020.
- Cancels all <u>school-related extracurricular activities</u> through May 31, 2020.
- Requires <u>restaurants</u> and <u>bars</u> to close their dining areas and move to takeout, delivery, and/or curbside service only.
- - o They have tested positive for COVID-19.
 - o They have a fever of 100.4° F or above
 - o They have experienced sudden onset of a cough and/or shortness of breath
 - They reside or have resided with individuals who have tested positive for COVID-19 or have the above symptoms.
 - NOTE: The quarantine requirement excludes those individuals with seasonal allergies, COPD, or other diagnoses that may produce respiratory symptoms. Additionally, the directive doesn't apply to patients who have an alternative non-COVID-19 diagnosis from a healthcare provider. These patients should follow the treatment and guidance provided by their healthcare provider for such conditions.

- o Some individuals in home quarantine may not experience the onset of symptoms until the latter half of their 14-day quarantine period. In this case, the length of their quarantine may exceed 14 days. Individuals should remain in quarantine until 7 days have passed since onset of symptoms, symptoms have improved, and they have been fever-free for at least 72 hours without the use of fever-reducing medication.
 - NOTE: See the DHM for additional direction on household members living with those in quarantine.
- The DHM's limitation on public gatherings does not apply to:
 - Retail or grocery stores where people should maintain six feet of distance from one another.
 - Childcare centers that may be operated at a school per the Governor's executive order regarding childcare.
 - Other locations detailed in the DHM.

The Governor is encouraging residents to apply for unemployment wages. If you are denied Nebraska unemployment, you can then apply for COVID-19 unemployment.

Beauty salons and other businesses closed by the DHM are allowed to continue retail sales, provided they can maintain 6 feet social distancing and no more than 10 customers in their location. Additionally, business loans and grants are available at www.sba.gov.
